Ad copy put in the body of the newsletter will be received by all addressees. We cannot guarantee ad placements in the newsletters. Inserts are not available. All ads incorporated as full pages or partial pages in the newsletter. In addition, **PDF's of each newsletter are posted on the LAT website with all advertising copy included.**
